**A JOINT RESOLUTION OF THE CITY COMMISSION OF THE CITY OF
BRADENTON BEACH AND THE COMMUNITY REDEVELOPMENT AGENCY
OF THE CITY OF BRADENTON BEACH, AMENDING RESOLUTION NO. 18-
898 AMENDING THE CITY'S BUDGET FOR FISCAL YEAR 2018-2019; AND
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, IN ACCORDANCE WITH Section 166.241, Florida Statutes and Article II, Section 4 of the City of Bradenton Beach City Charter ("City Charter"), the City of Bradenton Beach City Commission ("City Commission") and Community Redevelopment Agency of Bradenton Beach ("CRA") adopted a Budget for Fiscal Year 2018-2019 by Resolution No 17-898; and,

WHEREAS, in accordance with Article IV, Section 8 of the City Charter, the City Commission and the CRA may during the Fiscal Year make appropriation amendments to the Budget and,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF BRADENTON BEACH AND THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF BRADENTON BEACH, FLORIDA, AS FOLLOWS:

Section 1. Budget Amendment. In accordance with Article IV, Section 8 of the City Charter, the Final Budget adopted as of Resolution No. 18-898 is amended and replaced with the Budget Resolution 19-923 as depicted on Exhibits A.

Section 2. This Resolution shall amend the budget of one or both governing bodies as applicable to their respective budgets. Further, any amendments to this Resolution may be effectuated by one or both bodies

Section 3. This Resolution shall become effective immediately upon its adoption.
