A new Permit Application from the new contractor must be submitted to the Building Department and/or the Subcontractor Verification form. Please be advised that the Building Department charges an administrative fee of \$100.00 per change of contractor and \$50.00 per subcontractor. A new Notice of Commencement form will be required.

**Request to surrender permits. The contractor/qualifier is no longer going to perform work.**

The contractor of record who is no longer going to perform work on a project must send a letter to the City of Bradenton Beach Building Department advising of this fact and include a copy of the permit. The letter must include the permit number, jobsite address and explanation as to why the permit is being surrendered.

A hold will be placed on the permit to prevent inspections until the owner has completed the hold harmless process to change the permit into the name of the new contractor or an inspection can be scheduled to verify what, if any, of the permitted work has been completed. The permit holder and property owner will receive written notification with reference to the change of contractor requirements and status of permit. No permitting fees will be refunded.

NOTE: Failure to complete the permitted work could result in Code Violations and the loss of use of the property/structure. Transferring the permit to another licensed contractor could save the expense and time of re-permitting the work that has been permitted already.
