RESOLUTION NO. 20-938**

General Notes:

1. **All permits are subject to the following non-refundable fees.** Fees may only be waived by the City Commission. A written request is required.
2. All City of Bradenton Beach After-the-fact permit fees are assessed at double the normal fee, plus original fees.
3. Permit Valuations will be determined from the proposal of work or contract signed by the owner and contractor. The valuation documentation must be submitted at the time of permit application. Post disaster valuations may be determined by the Building Official using the current ICC valuations table with regional multiplier or current estimating valuations.
4. Valuation base for fee calculations is rounded up to nearest \$1,000.
5. For those permits requiring detailed plan review a plan review fee of 15% of the total permit cost associated with Florida Building Code Compliance will be charged and collected. Repeat plan reviews for continuously noted violations are subject to Fl. Statute 553.80(2)(b).
6. NOTE: A flat fee of \$50.00 per trade will be charged for the following trades being added to a permitting request: gas, plumbing, mechanical, electrical and roofing.
7. A State Surcharge Fee of 2.5 percent of the fees associated with Florida Building Code Compliance will be collected for all permits pursuant to Fl. Statutes 553.721 and 468.631. \$4.00 minimum.
8. Permits may require Planning & Zoning, Floodplain, Stormwater and Public Works reviews in addition of Building Code review. Separate fees may apply.
9. \$75.00 Failed inspections fee. Re-inspections fees are subject to Fl. Statute 553.80(2)(C).
10. Professional time will be invoiced to the property owner where necessary. Where the City's cost exceeds any fee specified, the applicant will be notified to pay the entire costs thereof.
11. Private Provider Service established on a permit will have a 15% discount applied to the Valuation Fee of the permit. Private Provider services are subject to FL Statute 553.791 requirements.
12. The City may assess a \$75.00 search fee per person per parcel number for permit searches per FL Statute 553.80(7)(c).

V. CODE ENFORCEMENT FEES

Beach equipment items confiscated by the city and are not reclaimed will be auctioned every six (6) months. If items are held longer than seven (7) days, a storage fee of twice the normal fee will also be applied. Items will be photographed and marked identifying the location they were removed from.
